Rules for Ram Prairie Circuit Finals Rodeo Booths

1. All participants must furnish their own display equipment including a heavy-duty extension cord if electricity is required. Displays must be within the exact boundaries of your booth.
2. For safety purposes, no smoking or cooking of any type will be allowed in the booth area.
3. Exhibitors must collect sales tax on all sales.
4. Upon arrival, please check in with the vendor coordinator at the front of the expo center to receive tax packets, booth location, and additional information.
5. Removal of concession will be made no earlier than 12:00 midnight, Saturday, October 22th, 2016. The building will be open after show and again at 8:00am till 12:00 noon on Sunday, October 23th, 2016.
6. Exhibitors must move vehicles after unloading to the designated parking area, check with the check-in table.
7. Clean up: The exhibitor is responsible for the removal and disposal of all trash and keeping their booth area clean.
8. There will be no pets allowed except for service animals.
9. No sales of alcoholic beverages. (Excluding Circuit Vendor)
